



Drug Endangered Children (DEC): Identification and Response

Overview: Drug Endangered Children: Identification and Response will provide attendees with an introduction to South Carolina Drug Endangered Children's guidelines, which offer guidance for the multi-disciplinary response necessary when children are found to live in or exposed to environments where drugs are used, possessed, trafficked, diverted, and/or manufactured illegally. These guidelines include the response to children who are found to be present at clandestine drug labs or exposed to dangerous substances.

Who should attend? The individuals attending this course should be law enforcement and/or DSS caseworkers or investigators who will have direct duties and responsibilities involving Drug Endangered Children.
